法学博士号を有する中国最高人民法院の上級判事(第2級)である。

1999年から2005年まで、北京市門頭溝区人民法院で勤務し、その後3年間は、中国最高人民法院の中国応用法研究所で勤務した。2008年11月以降、中国最高人民法院の知的財産部において、知的財産権事件の審理に主に従事している。審理した複数の典型的事件が、知的財産権保護事件の年間上位10件に選ばれており、その中には、「クレイ・フィギュアリン・ザン(Clay Figurine Zhang)工芸カー・アニー・アーゼ」特許無効事件が含まれる。「一個財産権紛争の行為保全における法律適用の審理に関する若干問題に関する最高人民法院規定」の起草にも加わった。主要な著書として、「営業秘密の法的保護の実務」と題する書物の編集に携わっている。50を超える論稿を発表しており、その卓越した研究論稿に対し、10回以上にわたり州の表彰を受けた。

From 1999 to 2005, Judge Lang worked in the People's Court of Mentougou District, Beijing city. In the following three years, she worked in the Institute of Applied Law of China affixed to the Supreme People's Court of China. Since Novermber 2008, she has been working in the Intellectual Property Division of the Supreme People's Court of China and mainly engaged in intellectual property cases trialing. Several typical cases trialed by her has been selected as the top ten cases of intellectual property judicial protection of the year, including an unfair competition case involving "Clay Figurine Zhang Artwork", a patent invalidation case involving "heat stable glucoamylase". Judge Lang has participated in the drafting of "the Provisions of the Supreme People's Court on Several Issues Concerning the Examination of Law Applicable on the Preservation of Acts in Intellectual Property Disputes". As the main author, she has been involved in the compilation of the book called "Practice of Judicial Protection of Trade Secrets". With more than 50 papers published, Judge Lang has received provincial-level awards more than 10 times for her excellent papers in legal research.
