Kiyoshi MORI

Mr. MORI Kiyoshi was appointed as Commissioner of the Japan Patent Office (JPO) in July 2021. He manages JPO operations and oversees Japan's policy on patents, trademarks, and design rights.

Prior to his current appointment, Mr. Mori stayed in Kansai for four years and served as DG of the Kansai Bureau of Economy, Trade and Industry (2017-2019), and as an Executive Board Member and VSG of the Japan Association for the 2025 World Exposition (2019-2021), where he contributed to ensuring the success of the Expo 2025, Osaka, Kansai, Japan.

He joined the Ministry of International Trade and Industry in 1986. Since 2003, he held management positions in charge of energy cooperation and economic cooperation with the Middle East, Africa, Asia, etc. for 11 years consecutively. During that time, he led the formulation of "Strategy for Securing Energy Resources" and "Infrastructure System Export Strategy." After that, for three years, as DG for the International Affairs, Global ICT Strategy Bureau (Ministry of Internal Affairs and Communications) and DG for the International Cyber Economy Policy, he tackled the new issue of international coordination on Internet policy. As DDG for Policy Evaluation in the Minister's Secretariat, he also experienced the implementation of policy evaluation for the entire ministry.

Mr. Mori graduated from the University of Tokyo, Faculty of Law. He earned a Master in Public Administration from Harvard Kennedy School, and had experience as a Guest Scholar at the Economic Studies of the Brookings Institution, Director of Industrial Research at JETRO London, a member of the Governing Board at the International Energy Agency and a member of the OECD Committee on Digital Economy Policy.



Tomoya HASUI

Deputy Director-General, Economic and Industrial Policy Bureau, 2121-present.

Mr. Hasui graduated from the University of Tokyo, Faculty of Law in 1993. He joined the Ministry of International Trade and Industry in 1986. He served as Director, Policy Planning Division, Small and Medium Enterprise Agency(2012) and Director, Industrial Structure Policy Division, Economic and Industrial Policy Bureau(2016). He also had experience as Director, Metal Industries Division, Manufacturing Industries Bureau and Director(2020) and Policy Planning and Coordination Division(2021).



David J. KAPPOS

David Kappos is a partner at Cravath and leader in the field of intellectual property, including IP management and strategy, the development of global IP norms, laws and practices and the commercialization and enforcement of innovation-based assets. From 2009 to 2013, Mr. Kappos served as Under Secretary of Commerce and Director of the U.S. Patent and Trademark Office, where he advised the President on IP policy matters. He was instrumental in achieving the passage and implementation of the 2011 Leahy-Smith America Invents Act. From 2003 to 2009, he served as IBM's chief intellectual property lawyer.



Kamil KILJANSKI

Kamil Kiljański is currently head of the IPR unit at Directorate General for Single Market and Industry (DG GROW). Prior to this posting, he headed the units in charge of space data and international relations at Directorate General for Space and Defence (DG DEFIS), served as the Chief Economist at DG GROW and worked on regulatory matters in intellectual property and financial services at the (then) DG MARKT. Kamil began his career at the Commission in 2004 at the then newly established Chief Economist Team of DG Competition. Prior to that, he had been a senior economist at a micro-economic consultancy in its London office. He holds a PhD in economics and an LLM.



Yoshiyuki TAMURA

Yoshiyuki Tamura is a professor at Graduate Schools for Law and Politics, The University of Tokyo, and an Emeritus professor at Hokkaido University. His research interests cover overall field in Intellectual Property Rights. He graduated from Faculty of Law, The University of Tokyo. In 1999 he was an associate professor at the Hokkaido University, and from 2000 to 2019, he was an associate professor at the Graduate School of Law, Hokkaido University. From 2003 to 2012, he also worked as a program Leader in the Ministry of Education, Culture, Sports, Science and Technology (MEXT) COE Program. He has been in his current position since 2019.



Evelina KURGONITE

Evelina Kurgonaitė is the Secretary General at the Fair Standards Alliance – a Brussels-based association that advocates fairer licensing of standardised technology in the development and rollout of the IoT. Ms Kurgonaitė previously served as Head of Policy Strategy and Legal Counsel at Samsung Electronics in Brussels. She has 15+ years of experience in EU & competition law and public affairs. Having spent seven years in private practice – including at Sidley Austin and Morrison Foerster – Ms Kurgonaitė established and managed the European arm of global news service PaRR, part of the Financial Times group at the time. She holds LL.M from Helsinki University and MA from King's College London. Ms Kurgonaitė is the founder and chair of Women AT (W@) – a platform that connects and promotes women professionals around the world.

Kenichi Nagasawa has been working in the IP field since he joined Canon in 1981. He became the head of Intellectual Property and Legal Headquarters of Canon in 2010, after working as the head of IP sections of oversea subsidiary sales companies.
