Notes

1. This Trademark Examination Manual uses the classes of the Trademark Examination Manual Classification Chart to facilitate use, and to simplify the process for making future amendments and additions.

The classes are based on the classification used in the Patent and Utility Model Examination Manuals.

Specifically, as the classification chart shows, the classes are based on the 11 class groups that were divided according to the sequence of the practical procedures of the trademark examination. These 11 groups are further each divided into 10 subgroups. These subgroups were organized by taking those items that were closely interrelated and then grouping them according to their importance and frequency of practical use. As a result, a total of 110 classes comprise the classifications.

Those items that do not fall into the above classifications were arranged as seen fit.

The columns that do not have a title within the classification chart are reserves for future additions. Thus the blanks show that no title was prepared, in anticipation of the contents of the items that are to be added in the future.

2. Class number

One hundred and ten two-digit numbers ranging from 00 to A9 are used as the basic class number, each of which represents a unique category of items.

The two digit number that follows the basic class number represents the order in which the explanation items are listed. A dot [.] has been inserted between the two sets of two digit numbers to comprise one classification number. (For Article 3 and Article 4, these are listed following the order of the Articles. The single-digit following the basic class number represents paragraphs, the two and three-digit numbers represent items. A dot [.] and a two-digit number following these numbers represents the order in which the explanation items are listed.)

- 3. Types of applications covered:
- (1) Handling that only applies to international applications is indicated by attaching a class number beginning with a basic class number from A1 to A9, such as A1.01.
- (2) Handling that only applies to international trademark applications is indicated by attaching a class number beginning with a number from 70 to 79, such as 13.71.
- (3) Handling that only applies to domestic trademark applications and not to international trademark applications is indicated by describing the following in the last "line: "[Note] This handling does not apply to international trademark applications."
- 4. The classification numbers with parentheses in the index either include items that have been classified into another place, items which have been deleted due to amendments and other adjustments, or items that have been transferred to another classification place before the

contents were amended.

Those items that contain quotations and those items that have been transferred to a different classification place will show the original source of the quotation for the former, and the transferred classification place for the latter. $[\rightarrow \text{class number}]$

5. The [(\rightarrow class number)] in the index and main contents shows that the part contains the main contents of the item and should be referenced.

Those class numbers that are parenthesized as explained above but only have two digits indicate that all of the items included in the basic class number should be referenced.

- 6. When other manuals such as the Formality Examination Manual are listed in the bibliography, the title of the manual and the class number are indicated with parentheses at the pertinent location.
