Nguyen Nhu Quynh

Dr. Nguyen Nhu Quynh is currently Deputy Chief Inspector of the Ministry of Science and Technology of Vietnam. She obtained her master's and doctor's degrees of laws majoring in Intellectual Property and international trade from Lund University, Sweden. Dr. Nguyen Nhu Quynh had worked for WIPO as a legal expert. She had also been a lecturer at Hanoi Law University for many years prior to assuming her position in charge of IPR enforcement at the Ministry of Science and Technology. Dr. Nguyen Nhu Quynh is the director of the Standing Committee of the Program on Prevention of Infringement of Intellectual Property Rights in Vietnam (Program 168). She is very active in elaboration of Intellectual Property-related policies and laws. She presides and directly engages in the elaboration of various Intellectual Property-related legal documents, namely the Law on Intellectual Property, the Decree on Sanctioning of Administrative Violations. She is also the Head of an inter-sectoral delegation with its members being representatives from ministries/agencies engaged in handling intellectual property rights infringements (including patents, trade secrets, industrial designs, trademarks, trade names, domain names, unfair competition). At the same time, Dr. Nguyen Nhu Quynh also participates in many international cooperation activities in the field of Intellectual Property, being chairperson and speaker at many international and domestic conferences on Intellectual Property.
