When a trial for invalidation, etc. (including a retrial) is filed, a chief administrative judge notifies a trial number, etc. to an exclusive licensee (an exclusive right holder to use) and other holders of registered right (such as pledgees).

- When a demand for an invalidation trial (including a trial for invalidation for registration of an extension of the term and a trial for rescission) is filed, a notice of trial (Form 1).
- When a patent (trademark registration) opposition is filed, a notice of opposition (Form 2, Form 3).
