The following communication, dated 7 October 2014, is being circulated at the request of the delegation of Japan.

1 TECHNICAL AND FINANCIAL COOPERATION IN THE FIELD OF INDUSTRIAL PROPERTY RIGHTS

1.1 Voluntary Contributions for WIPO Funds-in-Trust/Japan

- 1.1. Since 1987, the Government of Japan has been providing voluntary contributions in the field of industrial property to the World Intellectual Property Organization (WIPO). The "WIPO Funds-in-Trust/Japan" (FIT/JP) in the field of industrial property was established with these voluntary funds. The FIT/JP is used to finance various projects for WIPO member States in the Economic and Social Commission for Asia and the Pacific (ESCAP), such as holding IP office conferences or symposia, welcoming trainees and IPR research students, sending Japan Patent Office (JPO) officials and supporting for the automation and modernization of IP offices. The voluntary fund for the Japanese fiscal year (FY) 2014 amounts to 4.33 million Swiss francs.
- 1.2. In addition to the above, since FY 2008, the Government of Japan has been providing a new Japan Funds-in-Trust programme for Africa to the amount of 1.1 million Swiss francs annually. This fund will support activities aimed *inter alia* at strengthening the legal and administrative frameworks for Intellectual Property (IP) protection, automating and modernizing IP infrastructure to ensure high quality service to users, and sharing the experience of Japanese SMEs and experts in business oriented IP management and human resource development in Africa.

1.2 Programmes by JPO

1.2.1 Training Programme

1.3. In order to support developing countries to implement the TRIPS Agreement, Japan has been welcoming trainees from these countries. Between April 1996 and March 2014, Japan welcomed 4,257 trainees in both the public and private sectors from 71 countries and regions, primarily in the Asia-Pacific region. In the future, with the goal of the efficient implementation of laws in mind, Japan is scheduled to proceed with human resource development activities emphasizing the area of enforcement of intellectual property rights (IPR).

1.2.1.2 Training programmes for government officials

1.4. The JPO has been holding group training courses about industrial property rights for government officials. In FY 2013, 13 group training courses were held and 192 participants in total were welcomed (see Annex Table 1).

1.2.1.3 Training programmes for private sectors

1.5. The JPO has also been holding group training courses on industrial property rights for trainees from the private sector. In FY 2013, 4 group training courses were held, and 74 participants in total were welcomed (see Annex Table 2).

1.2.2 Long-term Fellowship

1.6. Under the long-term fellowship project funded by WIPO FIT/JP, two trainees, from Malaysia and Philippines, were invited to Japan in FY 2013 to study IP issues for a period of six months. In FY 2013, the JPO welcomed two trainees on the long-term fellowship, one from Indonesia and one from Myanmar, for about six months under an independent project.

1.2.3 Seminar on Intellectual Property Rights for Alumni Association Members

- 1.7. The JPO has suggested to the trainees that an alumni association be established to help disseminate information on IP systems in their home countries and to keep the members of the association informed of current IP developments. The JPO has conducted follow-up seminars in various Asian countries for those who had completed training programmes in Japan, in order to sustain the fruits of the training programmes and contribute to human resources development.
- 1.8. When the JPO receives a request from an alumni association to assist them in conducting an IP seminar, the following types of assistance is provided: financial assistance to meet the cost of holding the seminar, and the sending of Japanese speakers to the event.
- 1.9. In FY 2013, follow-up seminars were held in Viet Nam, Thailand and Malaysia.

1.2.4 Expert Missions

- 1.10. Experts and seminar speakers specializing in various areas of IPR are sent by the JPO through WIPO FIT/JP and the Japan International Cooperation Agency (JICA) mainly for periods of about two weeks. The experts mainly provide on-site instruction regarding examination practices, computerization and so forth.
- 1.11. The JPO has sent long-term experts under the JICA scheme in order to engage in JICA technical cooperation projects being implemented in the IP office of the respective recipient countries.
- 1.12. In FY 2013, 8 experts were sent under the WIPO scheme, and 11 experts were sent under the JICA scheme.

1.2.5 Symposia

1.13. In FY 2013, 12 symposia were held with the support of funding from the WIPO FIT/JP (See Annex Table 3).

1.2.6 Provision of the "Patent Abstracts of Japan (PAJ)" on CDROM

1.14. There has been a problem of third parties obtaining patents in other countries for the inventions for which applications have already been filed in Japan. To help prevent this problem and improve the quality of examinations in developing countries, the JPO has been publishing the CD-ROM version Patent Abstracts of Japan (PAJ). PAJ contains English translations of bibliographic data and patent abstracts as well as representative drawings published in the Kokai Tokkyo Koho, which means publications of unexamined patent applications. Since April 1995, the JPO has been

providing PAJ on CD-ROM free of charge to foreign organizations/institutions including major IP Offices and international organizations, and as of August 2014, about 80 organizations/institutions receive them on a regular basis.

1.2.7 Project to Publish (in English and Japanese) the Industrial Property Laws and Regulations in Effect in Various Countries

- 1.15. The JPO translated laws and regulations, which were related to the industrial property rights of major developed and developing countries, into English. From 1997 to 2003, the translations were published as CD-ROMs equipped with searchable indexes.
- 1.16. Since 2004, the JPO has provided the laws and regulations of various countries and regions through its website. At present, translations of the laws and regulations of about 90 countries and intergovernmental organizations can be browsed on the JPO website.

1.2.8 Assistance in Search and Examination - WIPO/State-of-the-Art Searches for Developing Countries

1.17. Since 1975, the WIPO has been conducting a "State-of-the-Art Searches Programme" by which IP offices of advanced countries have been making search reports for developing countries in order to provide the latter with such information at no charge within the framework of the WIPO Patent Information Services. The JPO reached an agreement with the WIPO on 23 September 1984 in terms of cooperating with it, and has been carrying out searches concerned from the standpoint of international contributions since then.

1.3 JICA projects

1.3.1 Technical Cooperation Projects

1.18. In the field of Intellectual Property, JICA has implemented various technical cooperation projects, which consist of sending of JICA experts, training of local officials for 'capacity development', supply of equipment. For instance, since 2012, a project has been conducted to strengthen the enforcement of intellectual property rights in Viet Nam (see Annex Table 4).

1.3.2 Group Training Course

1.19. JICA also has implemented group training courses of intellectual property. In cooperation with the WIPO and Kyoto Comparative Law Center (Non-Profit Research Organization), JICA implemented two-month training on the legal system of IPR and the Enforcement of IPR for officials from enforcement-related government agencies from around the world (FY2000-2012). Furthermore, in FY2010 and FY2011, JICA conducted in Japan five days training of IP Management, Administration, Registration and Enforcement for officials of Republic of South Africa.

2 TECHNICAL AND FINANCIAL COOPERATION IN THE FIELD OF COPYRIGHT

2.1 JCO Programmes

2.1. The Japan Copyright Office (JCO), agency for cultural affairs, has been planning and carrying out the following programmes with a view to contributing to the development of copyright systems in developing countries as well as to strengthening regional cooperation among Asia-Pacific countries.

2.1.2 APACE Programme (since 1993)

2.2. The "APACE (Asia-Pacific Copyright Systems Enhancement) Programme" was started in 1993 in cooperation with the WIPO, targeting Asia-Pacific countries. The APACE Programme consists of the following eight activities:

2.1.2.2 Annual Regional Workshop (since 1993)

2.3. Annual regional workshop has been organized with the fund of WIPO/FIT Japan since 1993. In 2013, Asia Pacific Regional Symposium was held in Thailand where 20 participants from Asian and other countries discussed the necessity of developing national copyright strategies and policies (see Annex Table 5(A)).

2.1.2.3 Training Programme in Tokyo, Japan (since 1994)

2.4. Since 1994, the JCO has been providing training in Japan, in cooperation with WIPO, to participants from Asian countries. In 2013, a training course on enforcement of copyright and related rights took place in Tokyo (see Annex Table 5(B)).

2.1.2.4 Experts Missions (since 1999)

2.5. This programme started in 1999, in order to assist countries in developing and strengthening infrastructure for the protection and management of copyright and neighbouring rights. In 2010, experts were sent to Kathmandu in Nepal to advise on collective management of copyright and related rights.

2.1.2.5 Training on Collective Management (since 2000)

2.6. This programme started in 2000. It is an on-the-job training for staff of collective management organizations or government officials in developing countries. In 2013, a study visit to collective management organization in Japan was arranged for 6 participants from Indonesia, Malaysia and Thailand (see Annex Table 5(C)).

2.1.2.6 National Seminar on Copyright and Neighbouring Rights (since 2000)

2.7. This programme started in 2000, in order to promote awareness of the protection of copyright and neighbouring rights, and the role it can play in cultural and economic development of developing countries. In 2013, this seminar was held in Bhutan and Brunei Darussalam, with more than 70 participants in total both from government agencies and private sectors in these countries (see Annex Table 5(D)).

2.1.2.7 National Workshop for the Production of a Handbook on Copyright (since 2011)

2.8. This programme started in 2011, in order to facilitate better understanding in developing countries of the issues related to the effective use, protection and management of copyright and related rights. In 2012, 25 participants mainly consisting of language experts, journalists, publishes and writers benefited from this workshop in Viet Nam (see Annex Table 5(E)).

2.1.2.8 Sub-Regional Roundtable (since 2003)

2.9. This programme started in 2003, in order to promote awareness of the importance of protection of copyright and related rights, and to discuss available opportunities for the use and management of copyright to support business activities in copyright-based industries. In 2010, this roundtable was held in Bandung, Indonesia, having 16 participants from Asian countries.

2.1.2.9 Research Project

2.10. So far, the studies on the economic contribution of copyright-based industries to the national economy have been conducted for Brunei Darussalam, Malaysia and Philippines.

2.1.3 Asia Copyright Conference

2.1.3.1 Asia-Pacific Copyright and Neighbouring Rights Seminar (since 1997)

2.11. This programme started in 1997, to provide participating copyright experts of Asia-Pacific countries with opportunities to exchange information and viewpoints as well as to discuss possible regional common positions and/or actions in the future. The title was changed to "Asia Copyright Conference" in 2010.

3 TECHNICAL AND FINANCIAL COOPERATION IN THE FIELD OF PLANT VARIETY PROTECTION

3.1 Cooperation through the UPOV

- 3.1. In the form of a Funds-in-Trust to the UPOV, the Government of Japan has supported programmes on plant variety protection systems.
- 3.2. National and international seminars have been held since FY 1991 for the purpose of contributing to promotion and establishment of PVP systems. Asian Regional Technical Meetings have been held since Japanese FY 2000, in order to provide practical knowledge and techniques related to PVP, as well as to promote regional cooperation in examination. In 2013, a Joint Workshop on DUS Test and Molecular Techniques was held in China having 13 participants from Asian countries including Brunei, Malaysia and Thailand.

3.2 JICA GROUP TRAINING COURSE

3.3. This JICA training course started in 2000 in cooperation with the Ministry of Agriculture, Forestry and Fisheries and NCSS (National Center for Seed and Seedling) to contribute to the establishment of PVP systems. In 2014, a Group Training Course was held in Japan having 11 participants from 11 countries (Burkina Faso, Cambodia, Ethiopia, Indonesia, Kenya, Lao PDR, Malaysia, Moldova, Myanmar, Sri Lanka and Viet Nam) (see Annex Table 6(A)).

3.3 Cooperation through the East Asia Plant Variety Protection Forum

- 3.4. To facilitate establishment and international harmonization of PVP systems in East Asian countries, the East Asia Plant Variety Protection Forum was set up in 2008 with participation of ASEAN countries, China, Republic of Korea and Japan.
- 3.5. Various cooperative activities which Japan had proposed in this forum were implemented. In 2013, Workshop for Cooperation in Harmonization of Test Guidelines and DUS Test was held in Viet Nam, Seminar on Plant Variety Protection was held in Indonesia, Cambodia, Lao PDR, Malaysia, Myanmar and Viet Nam, and Training Course was held in Japan (see Annex Table 6(B)-(D)).

4 TECHNICAL AND FINANCIAL COOPERATION IN THE FIELD OF BORDER MEASURES

4.1. The Ministry of Finance of the Government of Japan has provided a scholarship programme, training courses, expert missions on the TRIPS Agreement in the field of border measures for the enforcement of IPRs. The main purpose of these programmes is to assist in the smooth implementation of the TRIPS Agreement by customs officials in developing countries in the Asia-Pacific region. In FY2013, the scholarship programme and training course were held in Japan, with 8 and 12 participants respectively (see Annex Table 7(A) and 7(B)). Furthermore, experts were sent to 6 countries in FY2013 to advise its customs officers on knowledge and technique in the field of IPR border enforcement (see Annex Table 7(C)).
