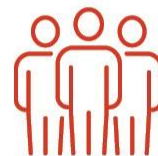

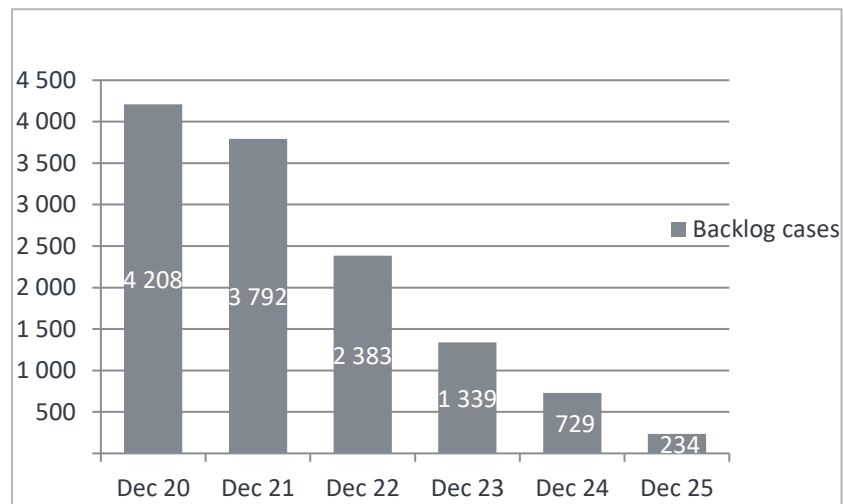
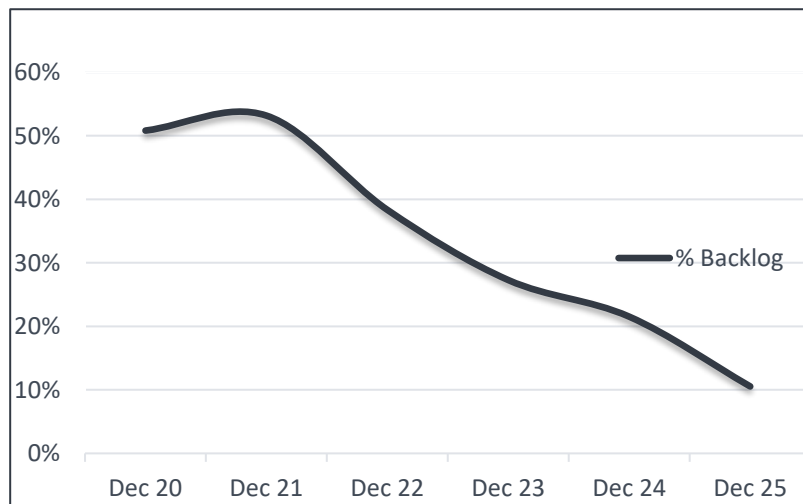

ENLARGED BOARD OF APPEAL

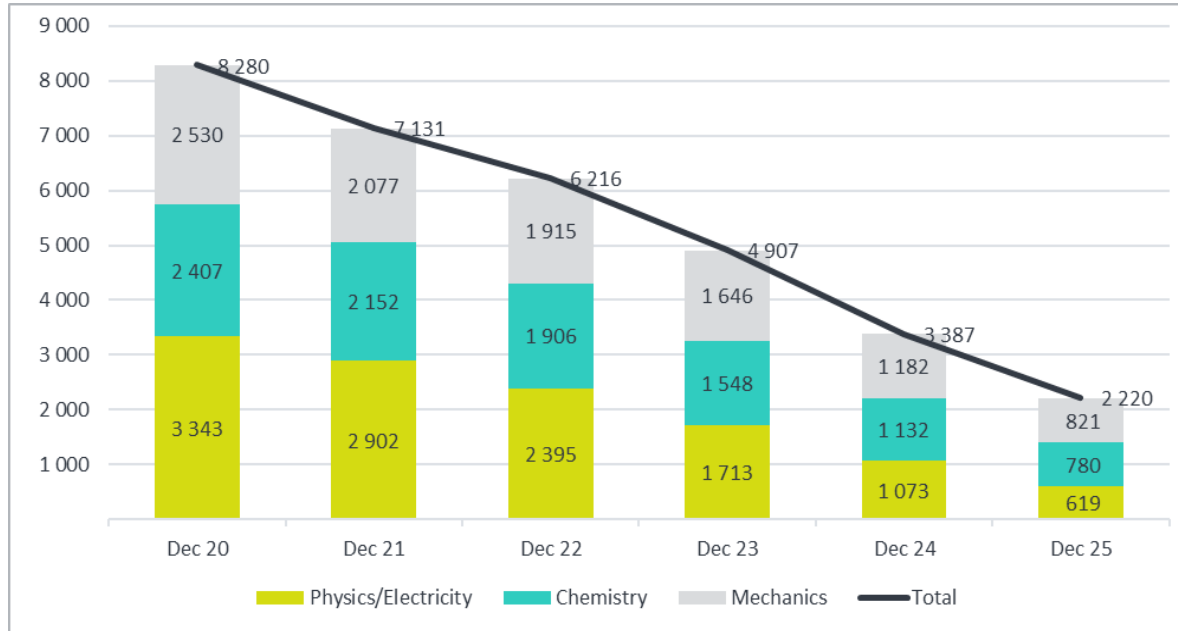
- New decisions:
 - [G 1/24](#) “heated aerosol” on 18 June 2025: referred by [T 439/22](#) in June 2024
 - [G 1/23](#) “solar cell” on 2 July 2025: referred by [T 438/19](#) in June 2023
 - [G 2/24](#) “skin cleanser” on 25 September 2025: referred by [T 1286/23](#) in November 2024
- Pending referral [in case G 1/25](#) “hydroponics”: referred by [T 697/22](#) on 29 July 2025
- Petitions for review under Art. 112a EPC
 - 24 received in 2025 (5 less than in 2024)
 - 47 settled in 2025 (24 more than in 2024)
 - 27 pending on 31 December 2025 (23 less than on 31 December 2024)

PENDING CASES OLDER THAN 24 MONTHS

- On 31 December 2025, **10.5% pending cases older than 24 months** (down from 21.5% on 31 December 2024). Mechanics 5.7%, chemistry 4.4%, physics/electricity 24.7%
- Cases older than 24 months have decreased from 729 at the end of December 2024 to **234 at the end of December 2025**

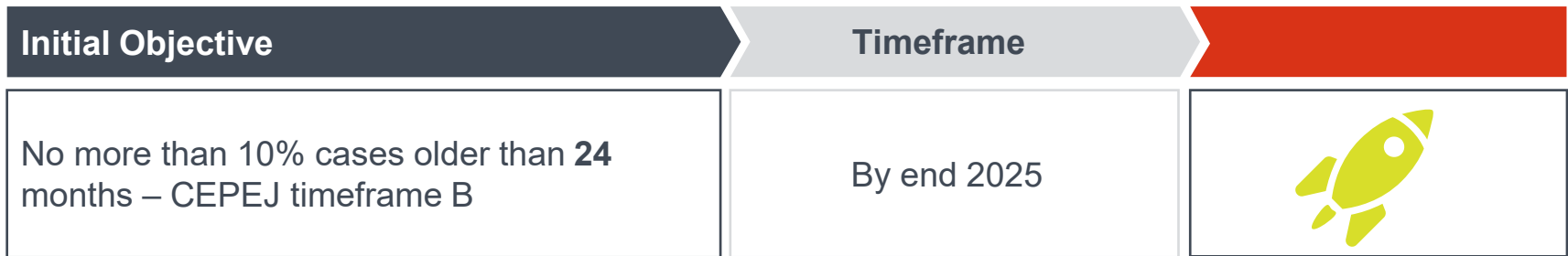


NUMBER OF PENDING CASES (BY TECHNICAL FIELD AND OVERALL)



- On 31 December 2025, there were **2 220** technical appeal cases pending, **34% fewer** than on 31 December 2024
- In 2025 there were **768** withdrawals after a substantive communication of the board, **24.2% fewer** than in 2024

2025 STRATEGIC OBJECTIVE



- The timeliness objective was met by two of the three technical fields – the BoA as a whole are expected to meet the objective in the first half of 2026
- Prioritising oldest cases continues to be a focus

OBJECTIVE FOR 2026 AND BEYOND

No more than 10% cases older than **24** months – CEPEJ timeframe B

Timeframe

To be continued in 2026
and 2027

- PBoA has mandated a task force to propose a timeliness objective applicable as of 2028

- Second series of quality-focused decision-making workshops
- Update of internal working aids to reflect first series of workshops
- Second edition of the quality-focused decision making paper
- PDC talks and presentations
- External exchange with judicial counterparts and stakeholders
- Dialogue with the Office
- Increased availability of legal resources

DIGITALISATION AND ARTIFICIAL INTELLIGENCE

- Developments in Digitalisation and AI continued to be actively monitored
- Initiatives include:
 - **case management system**: completion of a proof of concept for a modernised case management system
 - **search tools and decision publication process**: continued progress on improving search functionality and streamlining decision publication process
 - **internal guidance document** on the use of AI-based tools at the BoA regularly updated
 - **conducting a feasibility study** on audio recording of oral proceedings and AI processing of transcripts
 - **developing a training programme** for BoA staff on the use of AI-based tools
