


Changes in the Number of Patent Applications in the World

五庁 (IP5) の特許出願件数の推移





日本居住者の海外への特許出願件数の推移





Changes in the Number of Patent Registrations in the World



IP5の特許登録件数の推移







世界の意匠登録出願件数の推移





世界の意匠登録出願の意匠数の推移



 意匠五庁 (ID5) の意匠登録出願件数の推移








Changes in the Number of Design Applications Filed with Foreign IP Offices by Residents of Japan

日本居住者の海外への意匠登録出願の意匠数の推移



世界の意匠登録件数の推移



世界の意匠登録の意匠数の推移



ID5の意匠登録件数の推移








Changes in the Number of Design Registrations Filed with Foreign IP Offices by Residents of Japan

 日本居住者の海外での意匠登録の意匠数の推移






Changes in the Number of Trademark Applications in the World



日本居住者の海外への商標登録出願件数の推移




Changes in the Number of Trademark Registrations in the World

TM5の商標登録件数の推移


