背景 - インド特許庁への特許審査ハイウェイ申請について

- インド特許庁へ特許審査ハイウェイ（PPH）申請を行う際には、審査官に出願が割り当てられていないことが要件の一つとなっています。

- インド特許庁へPPH申請を行う場合には、次スライド以降に記載の方法で事前に割り当て状況をご確認ください。

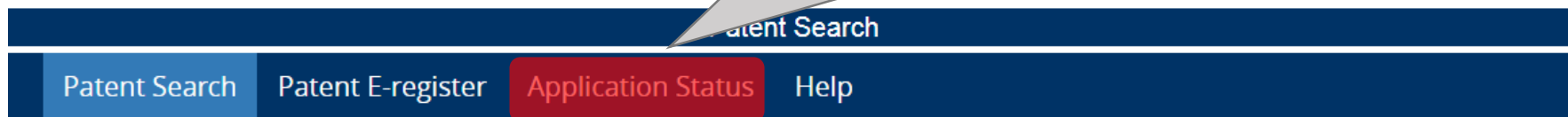

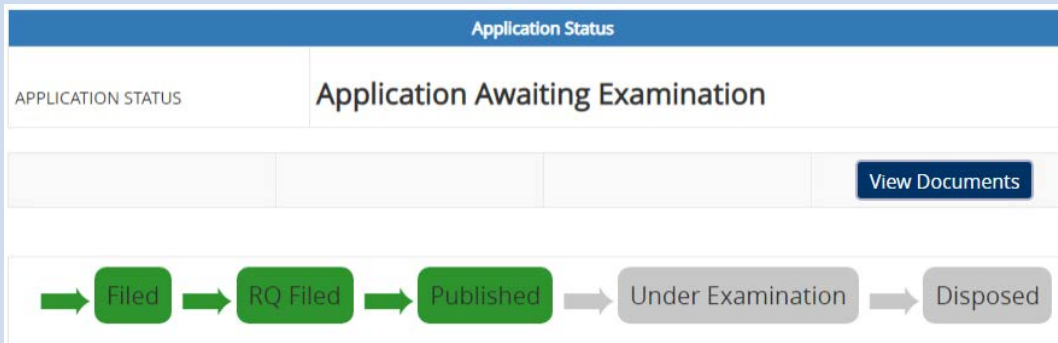

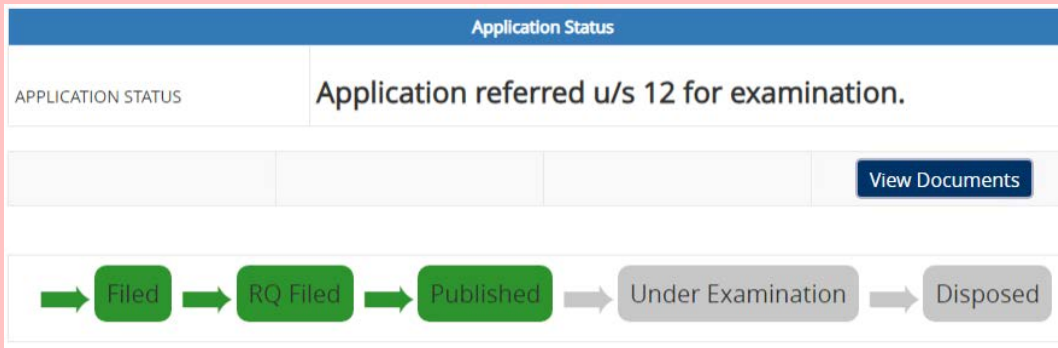

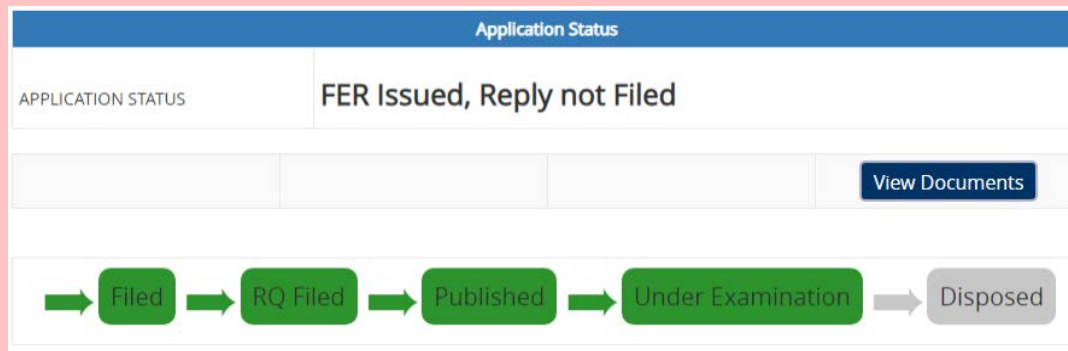
